### **Old Business**

**Sectional/Pairs Final Update** – Meghan provided an update on Sectionals. LSC received a check for their portion already. Conversations have occurred with US Figure Skating about coming back to East Lansing in the future. Overall – great success. Lesson learned - practice ice was a huge opportunity for revenue, as well as having both pairs and single events. Summer thanked Meghan and the Greater Lansing Sports Authority for their hard work. Meghan will drop off officials' gifts at the hotel, on behalf of GLSA.

**Recent Purchases: Spinner and Senior banners**- Spinner has been purchased (cost: \$3,790). A letter gifting the spinner to the rink will be sent by Summer. Senior banners have also been purchased. Worked with Michelle Hoffman – six seniors were honored. Will be hung in the lobby by the rink.

**Code of Conduct Violation Summary**- Summer provided an update on a code of conduct violation. A meeting was held between board president, skating director, and individual involved. Successful resolution was met; no further action will be taken.

**Spring Banquet location** -Josie has confirmed Eagle Eye for May  $7^{th}$  from 1 pm - 3 pm. Sign up reminder and save the date will be sent by Summer.

**Ice Show Contribution decision** – Erin has shared a breakdown/itemized list of potential costs. LSC will reimburse up to \$2000 of expenses for Ice Show. Brenna made a motion to reimburse Erin for up to \$2000 of ice show costs. Erica seconded the motion. Motion approved.

**Exhibitions: Adult and VanCamp-** Exhibition was held this past weekend as part of the freestyle session for skaters competing at Midwestern Adult Sectionals. Brenna set up a table to honor them; Summer provided a card, skater gifts have been purchased, and flowers for each participant. VanCamp exhibitions were/will be done as part of their practice ice on four separate dates.
